

UCSC Faculty Association Election Notice 2013 Proposed Change to Bylaws and Dues Structure

May 18, 2013

This letter is being distributed to members of the SCFA.

SCFA BALLOT 2013

To the Members of the Santa Cruz Faculty Association:

It is time to vote on proposed dues changes and to renew the SCFA Board with elections!

Dues Restructuring and amendment to the SCFA Bylaws:

The SCFA previously sent a notice to the membership introducing a new dues structure which would include a \$10./per month first year introductory fee for all faculty regardless of status.

We also reduced the monthly fees for Assistant Professors from \$17/per month to \$10/per month. We are now asking the membership to approve this change.

In order to avoid this confusion in the future, we also ask that you approve the following change in our bylaws to allow the Board to change the dues amounts when the Board feels that it is appropriate without putting the matter to a vote of the membership.

Section 1.

Dues, graduated by faculty rank, shall be established by the Board subject to approval by a majority of members casting valid votes in a mail ballot. Changes in dues must be approved by a majority of members casting valid votes in a mail ballot. The Board shall develop a comparable and equitable dues structure to cover persons holding other titles, members on leave, and other special categories.

Proposed change:

Section 1. The dues shall be graduated by faculty rank on a twelve-month basis at the rates set by the Board for Assistant, Associate, Full, and Emeriti Professors. The Board may develop a comparable and equitable dues structure to cover persons holding other titles, members

on leave, and other special categories. Assessments shall be at the discretion of the Board.

We are now putting these two matters to the membership for a vote. If you oppose either the change in the dues structure or the amendment change, please advise us by responding to this email before the close of the election on June 3, 2013 .

Election Notice:

First, we wish first to thank Regina Langhout and Andrew Matthews, who have contributed their attention and wisdom to further the broad interests of UCSC Senate Faculty through the activities of the SCFA.

The SCFA Executive Board consists of a minimum of seven and up to eleven members, who serve staggered two year terms. Elections are held in the Spring of each academic year. In accordance with SCFA bylaws, a nominating committee has selected the following slate of candidates to fill BFA board positions. Thank you very much to the nominating committee Megan Thomas, Elizabeth Abrams and Avril Thorne.

Four continuing members of the Executive Board are: Shelly Errington, Joel Primack, Cindy Cruz, and Elizabeth Stephens (who will return in the fall to continue her term after having been on sabbatical this year).

The Nominating Committee proposes the following four SCFA members to serve on the Executive Board of the Santa Cruz Faculty Association for two-year terms beginning Sept 30, 2013. Two current members of the Executive Board, Ben Carson and Ben Crow, have agreed to serve a new term if re-elected. Two new Board members, Chris Connery and Ronnie Lipschutz, will join us for two year terms if approved by the membership.
